**RELEVANT PROVISIONS OF THE DISTRICT ADMINISTRATIVE BY-LAWS and
PROPOSED SPECIAL RULES OF ORDER
TOASTMASTERS DISTRICT 46
ANNUAL DISTRICT COUNCIL MEETING
May 18, 2019**

Registration

All members and visitors shall register and shall wear identification badges for admission to business meeting.

RELEVANT PROVISIONS OF THE DISTRICT ADMINISTRATIVE BY-LAWS:

(Do not need approval by the District Council)

Voting Body

Only members of the District Council composed of the Club Presidents, Club Vice Presidents Education or their designated proxies and the District Executive Committee, may introduce motions and vote.

Members of the District Executive Committee are the District Director, Program Quality Director, Club Growth Director, the Immediate Past District Director, Public Relations Manager, Administration Manager, Finance Manager, Division Directors, and Area Directors. [Article IX (a) Composition of the District Council and Article XI (a) District Executive Committee]

Quorum

A quorum shall be one-third (1/3) of the Club Presidents and Vice Presidents Education or their proxies

Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order, Newly revised (11th Edition), shall govern the Council Meeting in all areas to which they apply and in which they are not inconsistent with the By-Laws, Policies and Protocols of Toastmasters International and the District Administrative By-Laws.

PROPOSED SPECIAL RULES OF ORDER: (Submitted to the District Council for Approval.)

Motions and Debate

The maker of any motion and each speaker on any matter to be taken up by the District Council shall state his or her name, office and club represented when addressing the Chair.

No member shall speak more than once or longer than one minute on the same question, without the consent of the District Council granted by a two-thirds (2/3) vote without debate.

Debate shall be limited on all matters to a maximum of 10 minutes, except by permission of the District Council granted by a 2/3 vote without debate.

Announcements from the floor shall be limited to one minute.

Nominations

No candidate for Division Director shall be nominated in more than one Division. All nominations for the position of Division Director in all Divisions shall be completed and closed before voting shall be held.

Voting Procedure

Voting may be by ballot, show of hands, or voice vote as appropriate, as determined by the Presiding Officer of the meeting.

Appointment of Timer

The District Director or Presiding Officer shall appoint an official timer for the business meeting who shall signal speakers when their allotted time has expired.

Suspension and Amendment

These special rules may be adopted by a 2/3 vote of the District Council. These rules may be suspended, rescinded, or amended by a majority vote of the District Council, except items that specifically pertain to the District Administrative Bylaws.
